## Opening Plenary: Building Livelihoods for Youth: Harnessing our Efforts and Bridging Knowledge Gaps

## Break-Out Sessions I: Core Elements and Challenges of Livelihood Interventions

These sessions are designed to focus on core components of youth employment and entrepreneurship programs and major challenges faced by implementers.

## Break-out A: Meeting the Needs of Youth & Employers: The "Dual-Client" Approach

This session will explore ways to assess supply and demand and how to use a dual-client approach to ensure that youth employment programs respond to the needs of rapidly changing labor markets. The discussion will compare experiences across regions. Among the topics for discussion: which competencies are needed in an organization to conduct dual-client assessments, considering different market environments, scope, time, and resources available? What are effective strategies for engaging youth in these efforts? Following the panel discussion, participants will have an opportunity to "learn by doing" – breaking into groups and planning an imaginary dual-client assessment.

## <u>Break-out B:</u> Career Guidance: Approaches and Lessons for the Design and Incorporation of Career Guidance in Employability Programs

Career guidance is a critical part of youth employability programs to support successful transitions to the world of work. Such transitions are particularly challenging for disadvantaged youth, who often lack the social capital or access to the networks that can provide for their social and economic wellbeing.

Career guidance traditionally takes place in school settings. Most organizations working with disadvantaged youth, however, have not incorporated career guidance into their programming, nor are they prepared to provide these services effectively. Some topics to be explored in this session include: what are the key elements of a career guidance program? What approaches, methodologies and tools have already been developed? How would implementation work in an in-school or out-of-school setting? What are the roles and competencies of instructors, tutors, and facilitators responsible for providing these services?

#### Break-out F: Working with Employers to Achieve Employability Results

How, when, and where are effective win-win partnerships with employers established and sustained? Using small groups and moderated discussions, participants will collaboratively explore challenges and strategies for effective employer engagement to support youth employability programs. The discussion will focus on how the engagement of employers to ensure program design, implementation, and evaluation is relevant to the needs of both youth and the job market and can help successfully transition youth into productive internship and employment opportunities.

Among the questions to be explored: Who do you engage to move a partnership forward? How do you align your project-level goals (to help transition youth into employment) with employer goals? When do you engage potential partners—at early stages or later, when there's something tangible to discuss? Where are partnerships with employers built—at the local, regional, national, or international level?

## Breakout G: How does Youth Civic Engagement Help Livelihood Outcomes?

How do organizations integrate civic activities into youth employment and entrepreneurships training programs? Participants will work together to come up with proposals and designs for holistic livelihood programs based on their discussions.

## Breakout I: Reproductive Health Matters in the Context of Youth Livelihoods

Panelists will discuss the critical elements of engaging parents and community in ensuring healthy behaviors in youth and issues of gender and culture in reproductive health and family planning. ## **Break-out J:** Mentoring Young Entrepreneurs

This workshop will explore the fundamentals of establishing, maintaining, and assessing a youth mentorship program as part of an employability or entrepreneurship training program. Participants will work together in small groups to answer critical questions, such as: Who are mentors, why do they matter, and what support do they require? What are the key success factors in building positive mentor/mentee relationship? How are effective mentor programs for young entrepreneurs structured, implemented, and evaluated? Speakers from organizations with successful mentorship programs in Egypt, Mexico, and Senegal will provide examples from their own experiences, offering participants the basic knowledge they need to begin establishing mentoring programs in their own country contexts.

## <u>Breakout K:</u> Building Strong Employability Programs that Support the Psycho-social Needs of Youth at risk

IYF's global partners are increasingly implementing youth employment programs targeted at highly vulnerable youth. These youth may face intense societal pressures or marginalization from their communities either because they lack education, family support or are economically disadvantaged. They may also be youth who are either living in violent circumstances or in post-conflict situations. This session examines the challenges and lessons learned in designing and implementing work force development programs targeted at at-risk youth.

Among the topics to be explored: How do youth employment programs create an enabling environment to best support the psycho-social needs of youth? How can practitioners and youth workers in the field ensure that the special needs of youth at risk are being met while still ensuring strong employment outcomes? This session will

share lessons learned from three of IYFs global partners who have designed employability programs for highly vulnerable youth in Mexico, the Caribbean and the United States.

Workshop B: How to Use Cloud Computing to Improve M&E Activities

Increasingly, development implementers are taking advantage of internet-based technologies that allow for online data storage and real-time reporting. Such a process stands in contrast to more common approaches to M&E, that use paper survey instruments entered into a spreadsheet and then sent to a donor or primary partner. Organizations have found that by using internet based solutions (e.g., salesforce, keysurvey, etc), their M&E processes become more efficient and accurate. The purpose of this workshop will be to demonstrate one example of how IYF has implemented cloud computing for M&E in a project. The demonstration will show participants the advantages of using such an approach as well as the specific practicalities that are needed in setting up such a system. Participants will leave with a clear understanding of what it will take to implement similar processes in their own organization.
